# **Additional Comments:**

• Connecticut must invest in the future by fighting for and passing Green New Deal legislation. In 2019, I cosponsored House Bill 5002, Connecticut's Green New Deal, and I am determined to continue to push for this important legislation. Future legislation should also include a provision that bans offshore drilling for oil and gas in the Long Island Sound. This ecosystem is fragile and we must preserve the biodiversity that it fosters on the shore and below the surface of the water. We must work to crack down on these gas companies as well that are polluting Connecticut and harming individuals with dangerous gas leaks. A New Green Deal should increase taxes on these companies and implement substantial penalization for polluting through gas leaks. This will create monetary incentives for these companies to become more environmentally friendly. We also need to hold these companies accountable for their mistakes by decreasing the amount of gas necessary to leak before a company must pay to repair the tank from 3% to 1%. However, this cannot be the end all be all solution. This is why future legislation should also begin to phase out Connecticut's reliance on these companies for energy and fuel and invest in renewable sources. Therefore, we must provide incentives in this legislation to purchase more energy efficient vehicles like Tesla and push for their direct sale so this environmentally friendly company is more accessible.

Additionally, new legislation should push for working towards a carbon neutral Connecticut by 2060 or 2070. This gives Connecticut 20-30 years after converting to fully carbon-free electricity. Thus, Connecticut will have time to invest in even more energy efficient technologies that will balance the emissions big business creates in order to allow for net zero carbon emissions. Connecticut must therefore create ambitious goals for energy efficiency in years leading up to this transition. An updated Green New Deal should mandate IGW of solar installations at least every 5 years.
