1) Open Question:

Through my two terms as a legislator I have actively advocated for several environmental priorities including TCI, House Bill 5004, and ebike rebates. I was successful in championing the ebike rebate and will continue to pursue opportunities to expand this to those most in need. I also am focused on building healthier communities with complete streets policies which have environmental benefits.

I expect going into 2025 my top environmental priority will be to resurface the priorities of House Bill 5004 and to expand our inclusion of complete streets in transportation and housing policy.
